## Planning enforcement

A new Rural Development Supplementary Planning Document (SPD).

The Supplementary Planning Document supports the implementation of policies relating to rural development in the East Suffolk Council - Suffolk Coastal Local Plan and East Suffolk Council - Waveney Local Plan policies.

The SPD provides guidance on a range of topics, including rural worker dwellings, rural annexes, rural residential curtilage expansion, rural buildings and barn conversions, economic development, equestrian development, tourism accommodation, small scale renewable energy generation, and wastewater management in rural areas.

## Green party adopt my policies and my vision

### **East Suffolk's environmental focus developed and delivered by the Conservatives set to continue under the current administration at East Suffolk**

I spoke at Full council in response to the Green and Lib Dem presentation on the environment vision for the new administration

With pride I am delighted to confirm although absorbed and rebranded as the Environment Impact Strategy under the new administration the environment direction of the council is basically the same the vision I delivered previously and at the July full council I was delighted to support the continuation of my vision through the environment impact strategy .

As cabinet member for the environment in the previous administration I made sure there was a strong focus on biodiversity with the introduction of an annual district wide spring litter pick and the flag ship policy of ' Pardon the weeds we are Feeding the bees campaign ' both campaigns sadly now abandoned by the Green party . However I am delighted to see free spring bulbs are still offered to communities, our waste trucks run on hydrotreated vegetable oil and robust air quality and environment planning guidance along with a strong recycling strategy are still in place .

This environment impact strategy is testament to the hard work I previously delivered and is a fitting legacy as we build environmentally sustainable communities for now and future generations
